AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR THE HERITAGE OF HAWK RIDGE COMMUNITY ASSOCIATION

THIS AMENDMENT is made as of the 15th day of April, 2014, to that certain Declaration of Covenants, Conditions, and Restrictions for the Heritage of Hawk Ridge Community Association recorded in Book 2574, page 197, in the Recorder of Deeds' Office of St. Charles County, Missouri, as amended from time to time (the "Declaration"). (Terms defined in the Declaration are used herein as defined therein unless otherwise indicated.)

RECITALS

- A. WBI Resolution, LLC, a Missouri limited liability company ("Resolution") is the "Declarant" under the Declaration.
- B. Article XIII, Section 3 of the Declaration permits the Declaration to be amended by Declarant for so long as Declarant owns any Lot or Unit within the Properties.
- C. At the time of this Amendment, Declarant still owns at least one Lot or Unit within the Properties.
- D. Article V, Section 6, of the Declaration sets forth certain provisions regarding an Operating Deficit.
- E. In accordance with Article XIII, Section 3 of the Declaration, Declarant desires to amend the definition of Operating Deficit in the aforesaid Article V, Section 6, as more particularly set forth in this Amendment.

AMENDMENT

NOW, THEREFORE, in accordance with Article XIII, Section 3 of the Declaration, the Declarant desires to amend the following:

- 1. Operating Deficit. Notwithstanding anything to the contrary contained in the Declaration, there shall be no Operating Deficit, unless and until all reserves are first exhausted. Accordingly, the term "Operating Deficit" shall be amended to be defined as the difference between: (i) the operating expenses of the Association; and (ii) the sum of (A) the total operating revenues of the Association from all sources including, without limitation, annual and special assessments, revenues generated from fees charged by the Association for use of the Common Areas, and investment income and (B) all reserves of the Association.
- 2. Except as otherwise provided herein, the Declaration shall remain unchanged and in full force and effect.
