3. Carts must be in good shape. Subject to staff approval.
4. Registration sticker must be displayed on the cart where it is clearly visible.
5. Any additional stickers or decals (other than Club Registration) are not permitted.
6. **Owners must provide Proof of Insurance, and continue to provide a current Certificate of Insurance with limits no less than \$30,000 to the Heritage of Hawk Ridge Community Association, with Heritage of Hawk Ridge, LLC and Walters Golf Management, Inc. listed as additional names insured.**
7. Lending or sharing of golf carts is strictly prohibited.
8. The annual registration fee of \$225.00 must be paid to Heritage of Hawk Ridge.
