- I understand that the **refund policy is on a pro-rata basis as follows:**
 - One (1) through sixty (60) days after purchase - 70%
 - Sixty-one (61) through one hundred twenty (120) days after purchase - 40%
 - Refunds will not be allowed, under any circumstance, beyond one hundred twenty days after the purchase date.
- I understand that any cart fees and applicable charges are not included in the Annual Golf Pass purchase price and are solely my responsibility.
- I will adhere to and be bound by all the present and existing rules and regulations set forth by the Heritage of Hawk Ridge Board of Directors.

Violations are subject to review by the Board of Directors / Golf Committee and could result in suspension of pass holder privileges.

Liability Waiver: I voluntarily assume all risks of accident or damage to my person or property and that of my family and guests. I/We currently own or are planning to purchase an electric golf cart. I/We understand that we must abide by the rules and regulations of the Association and Heritage of Hawk Ridge Golf Course. The guidelines are as follows:

1. Only electric golf carts are permitted.
2. Carts must be in good shape, subject to staff approval.
3. Registration sticker must be displayed on the cart where it is clearly visible.
4. Any additional stickers or decals are subject to staff approval.
5. **Owners must provide Proof of Insurance and continue to provide a current Certificate of Insurance with limits no less than \$30,000 to the Heritage of Hawk Ridge Community Association, with Heritage of Hawk Ridge, LLC and Walters Golf Management, Inc. listed as additional names insured.**
6. **Lending or sharing of golf carts is prohibited, with the exception that an owner may lend/share their cart with immediate family to include grown children (and spouses) and grandchildren with a valid driver's license.**
7. **All registrants must adhere to and be bound by all the present and existing rules and regulations set forth by the Heritage of Hawk Ridge Board of Directors. Violations are subject to review by the Golf Committee and could result in suspension of privileges.**
8. The annual registration fee of \$245.00 will be paid to Heritage of Hawk Ridge Golf Course.

Refund Policy (Pro-Rata Basis):

Days 1–60 after purchase: Eligible for a 70% refund

Days 61–120 after purchase: Eligible for a 40% refund

After 120 days from purchase: No refunds will be issued under any circumstances
